What is discrimination?

It is an unfair treatment on the grounds of sex, sexual orientation, nationality or ethnic origin, skin colour, age, religion, creed, belief or disability.

NO TOLERANCE FOR DISCRIMINATION!

The authorities of the faculties and the university are obliged to prevent discrimination and in justified cases ensure that the person who discriminates, including harassing or abusing other students or persons employed at the University of Warsaw faces appropriate consequences.

Whether the university is a place of tolerance and equality, where everyone is treated with respect and can count on support is up to all of us. Therefore, do not agree on unfair treatment and do react when you or some other person from your surrounding are discriminated against. Stand in defence of the discriminated person. Report the violation irrespective of whether it concerns you directly or not. Do not be indifferent.

The Rector's Committee for Preventing Discrimination

Members of the Committee provide counselling, conduct clarifying interviews with persons infringing the principle of equal treatment and, if necessary, initiate disciplinary proceedings against the persons who have committed the act of discrimination.
